## **Pegasus West Development**

The Secretary of State for Business, Energy and Industrial Strategy has been informed that Spirit Energy Resources Limited has submitted a letter of application to the Oil and Gas Authority in relation to the above Pegasus West Development project located approximately 107 km / 66 miles from the north Yorkshire coast at the Pegasus West well (054° 31' 20" N, 001° 25' 14" E, and located approximately 155 km / 96 miles from the north Norfolk coast at the Cygnus platform (054° 34' 10" N, 002° 17' 29" E). In accordance with the above-mentioned Regulations, this letter of application is supported by an Environmental Statement, copies of which may be inspected between 10 am and 4 pm on business days at Spirit Energy, 5th Floor, IQ Building, 15 Justice Mill Lane, Aberdeen, AB11 6EQ until close of business on 11/01/2019. As it appears to the Secretary of State that the carrying out of this project could have a significant effect on the environment of another EEA State, the Secretary of State would also intend to provide the relevant State with a description of the project together with available information regarding the possible transboundary impact of the project and the nature of the Environmental Statement decision process, so that the relevant State can decide whether it would wish to participate in that process.

of all representations the Secretary of State will either agree to the grant or refusal of the consent (with or without conditions). Notice of the Secretary of State's decision will then be published in the London, Edinburgh and Belfast Gazettes, and on the GOV.UK website.

Within six weeks from the date of publication of the Secretary of State's decision to agree to the grant of consent, an approval as referred to in regulation 11 or the imposition of a relevant requirement in respect of the project as referred to in regulation 11, any person aggrieved by the decision may apply to the Court. The Court may grant an order quashing the grant of consent, the approval or the imposition of the requirement where it is satisfied the action was done in contravention of the requirement to consider the Environmental Statement, any other relevant information representations received from relevant authorities or other interested parties. The court may also grant such an order where the interests of the aggrieved person have been prejudiced by a failure to comply with any other requirement of the Regulations. Pending determination of the application by an aggrieved person, the court may by interim order, stay the operation of the consent, the approval or the requirement.
